## Action Items

-Community fair overview and connecting to new families by combining the resources such as shoe collection, clothes closet, vaccine clinic, back to school registration for resources--the Goal: Making school supply train exclusively for Hallsville. Nurse staff meeting coming up 2.14 for input. HHS StuCo to possibly add clothes closet just for them, Gibson and Davidson.

-Summer enrichment, Title IV funded. Google form has been sent to HISD staff for input. Conclusions: elementary-outdoor games, ninja courses; higher-stem, coding, robotics. The session schedule will follow summer school, campuses and bus routes. How do we prioritize low socio economic and how to get them there?

-Additionally, adding a "learning bus" that can go to neighborhoods/families to build relationships with parents and provide summer learning for students. A bus has been donated by transportation and has been updated inside. The need is a wrap/paint for the exterior. A donor has been found, to be finalized. Anticipated roll out during community pep rally in August. The hope is to be able to help families with resources via learning bus wifi and computer access--all while providing learning access to the children.

-Fentanyl crisis information provided by Kelly Woods. Partnered with #UnitedAgainstFentanyl to bring #WalkForLives to Hallsville. This is a national walk to bring awareness to the fentanyl crisis. Following the walk will be various speakers and vendors. Asking for assistance in raising community awareness. Itinerary of the walk provided. Volunteer opportunity coming soon via Facebook link. Officer Miller is leading security and providing a safe walk route. Group is asking for any other information of families to honor during the walk, sponsors and vendors. At the end of March, pushing a youth driven social media. Officer Miller speaks about fentanyl crisis as top priority. All officers carry two doses of Narcan and every HHS classroom is trained and stocked also. Let's open conversation with parents to help bridge the technology gap with resources/speakers during the walk. Importance of SHAC partnering with teachers/parents to find school life-home balance and school for our students.
